THE CRISIS CENTER IS FOR YOUTH 21 AND UNDER WHO ARE IN NEED OF EMERGENCY SHELTER. ANY YOUTH, THE FIRST TIME THEY COME INTO SHELTER, ARE WELCOMED WITHOUT QUESTION. THIS PROCESS IS CALLED OPEN INTAKE. THE CRISIS CENTER PROVIDES SHELTER, FOOD, HEALTH, EDUCATIONAL, VOCATIONAL, CASE MANAGEMENT, COUNSELING, LEGAL ADVICE AND REFERRAL TO SUBSTANCE USE AND MENTAL HEALTH SERVICES. THS CRISIS CENTER IS OPEN 24 HOURS PER DAY, SEVEN DAYS A WEEK. DURING THIS FISCAL YEAR THIS PROGRAM SHELTERED 600 RUNAWAY, HOMELESS AND TRAFFICKED YOUTH. WE REUNITED 80 YOUTH WITH THEIR FAMILIES AND OVER 200 YOUTH MOVED INTO STABLE HOUSING.

RIGHT OF PASSAGE- OUR RIGHTS OF PASSAGE PROGRAM IS A 20 BED TRANSITIONAL LIVING PROGRAM LOCATED IN THE KENSINGTON SECTION OF PHILADELPHIA. THE RIGHTS OF PASSAGE PROGRAM PROVIDES TRANSITIONAL HOUSING SERVICES FOR UP TO 18 MONTHS TO YOUTH, 21 AND UNDER, INCLUDING INDIVIDUAL COUNSELING AND HELP WITH COMPLETING THEIR EDUCATION, FINDING JOBS AND PERMANENT HOUSING. OUR ROP PROGRAM PROVIDED HOUSING FOR 37 YOUTH. WE HAD 100% STABLE HOUSING DISCHARGE THIS YEAR. YOUTH RETURNED HOME, GOT THEIR OWN APARTMENTS AND WENT OFF TO COLLEGE.
